

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. HOW TO ENTER: Woman's Day Universal Orlando Resort Fall Sweepstakes (the "Sweepstakes"): To enter beginning September 10, 2019, at 12:01 AM (ET), through October 21, 2019, at 11:59 PM (ET) (the "Entry Period") go to familytrip.womansday.com on a computer or wireless device and complete and submit the entry form pursuant to the onscreen instructions. Important Notice: You may be charged for visiting the mobile website in accordance with the terms of your service agreement with your carrier. Please consult your wireless service provider regarding your pricing plan. You must use a Smartphone device to participate via your mobile phone. Not all mobile phone providers carry the necessary service to participate. Check your phone capabilities for specific Internet instructions. If your data usage exceeds what is allotted by your data plan, you could be subject to additional fees by your carrier. Please contact your mobile service provider with any questions regarding your bill. **Winner Selection:** Winner (individually and collectively, the "Winner") will be selected within one (1) month from the end of the Sweepstakes in a random drawing from among all eligible entries received. In the event the Sponsor does not receive any eligible entries, the Sponsor has the right to cancel the Sweepstakes. Drawing will be conducted by Woman's Day magazine, whose decisions are final. Odds of winning will depend upon the total number of eligible entries received. **Prizes & Approximate Retail Value ("ARV"):** One (1) Winner will receive a four (4) day, three (3) night trip for Winner and up to three (3) guests ("Guest") to Universal Orlando Resort in Orlando, Florida ("Trip"). Trip will include: (i) round trip economy class air transportation for Winner and up to three (3) Guests from a major commercial airport near Winner's home (as determined by Prize Provider in their sole discretion, subject to the below) to Orlando, FL; (ii) three (3) nights standard hotel accommodations (one room, quadruple occupancy, room and tax only) at Universal's Endless Summer Resort – Surfside Inn & Suites or at another Universal Orlando Resort hotel (as determined by Prize Provider in their sole discretion); (iii) non-exclusive ground transportation to and from airport and hotel in Orlando, FL; (iv) 3-Park 3-Day Park-to-Park theme park tickets for admission to Universal Studios Florida and Universal's Islands of Adventure theme parks and Universal's Volcano Bay water theme park for Winner and up to three (3) Guests; (v) and admission to one (1) Blue Man Group Show (exact date and time to be determined by Prize Provider in their sole discretion) for Winner and up to three (3) Guests. **The Approximate Retail Value ("ARV") of Prize is Three Thousand Eight Hundred Twenty-Four and 64/100 Dollars (\$3,824.64) which may vary depending on location of Winner's residence.** Any difference between the stated ARV and the actual value of the prize will not be awarded in any form. If in the sole judgement of Sponsor and Prize Provider, air travel is not required due to the Winner's proximity to the prize location, the Winner will pay for ground transportation for Winner and Guests. 3. ENTRIES: Limit one (1) entry per email address per day for Sweepstakes. Multiple entries from the same person on the same day will be disqualified. Entries become the property of the Sponsor and will not be returned. Proof of submission does not constitute proof of receipt. If applicable, inaccurate, lost, late, misdirected, damaged, manipulated, incomplete or entry forms that have been tampered with will be disqualified. Online entrants must have valid email address and it is entrant's responsibility to update Sponsor of any change in email address. If there is a dispute as to the identity of an online entrant, the prize will be awarded to the authorized account holder of the email address. The "authorized account holder" is defined as the natural person to whom the email address is assigned by an internet service provider, online service provider, carrier, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning the email addresses for the domain associated with the submitted email address.

If for any reason the Internet or mobile phone portion of the program is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes which corrupt or affect the administration, security, fairness, integrity, or proper conduct of this Sweepstakes, Sponsor reserves the right at its sole discretion to cancel, terminate, modify or suspend the Sweepstakes. Sponsor reserves the right to select Winners from eligible entries received as of the termination date. Sponsor further reserves the right to disqualify any individual who tampers with the entry process. Sponsor may prohibit an entrant from participating in the Sweepstakes if it determines that said entrant is attempting to undermine the legitimate operation of the Sweepstakes by cheating, hacking, deception or other unfair playing practices or intending to abuse, threaten or harass other entrants.
